

- WHEREAS**, the Rosebud Sioux Tribal Council approves the Legal Representation Agreement for the Native American Rights Fund (NARF) legal assistance and representation for the provision of certain legal services to the Rosebud Sioux Tribe in legal matters related to the allocation and distribution of Coronavirus Aid, Relief, and Economic Security Act ("CARES Act") Title V fund including communication with local, state and federal officials and agencies, legislative and administrative advocacy, and litigation without charge for attorney fees, expenses, and costs to the Tribe; and
- WHEREAS**, the Rosebud Sioux Tribe agrees to assign to NARF any and all right, allowable by law, to attorney fees, litigation expenses, courts costs, and attorney fees from the opposing party or parties and agrees that if the court allows the Tribe to recover cost and/or expenses paid directly to NARF for the costs and expenses, or the party advancing those costs and expenses; and
- WHEREAS**, the Rosebud Sioux Tribe agrees to the provision if NARF has a dispute regarding the terms of the contract, any such dispute will be brought in the Rosebud Sioux Tribal Court; and
- WHEREAS**, nothing in the Legal Representation Agreement shall be deemed a waiver of the Rosebud Sioux Tribe and its officers and employees' sovereign immunity from suit arising from the performance of their official duties; and

**THEREFORE BE IT RESOLVED**, that the Rosebud Sioux Tribal Council authorizes and approves the Legal Representation Agreement with NARF, legal assistance and representation for the provision of certain legal services to the Rosebud Sioux Tribe to represent the Tribe in legal matters related to the allocation and distribution of Coronavirus Aid, Relief, and Economic Security Act ("CARES Act") Title V fund; and

**BE IT FURTHER RESOLVED**, that the President of the Rosebud Sioux Tribe is authorized and directed to sign and execute the Legal Representation Agreement and any other supporting documents.
