**RESOLUTION ON LAKOTA-DAKOTA-NAKOTA TEMPORARY HOMELESS CAMP
ON THE TRIBES' RAPID CITY INDIAN TRUST LAND**

- WHEREAS,** the Cheyenne River, Oglala, and Rosebud Sioux Tribes (the "Tribes") own equal and undivided interests in approximately 117 acres of tribal trust lands in Rapid City, SD;
- WHEREAS,** The Tribes by adopting this Resolution hereby establish the Tribal Rapid City Indian Lands Committee composed of the Chairman or President of each Tribe and two additional members appointed by the respective Tribal Council from each Tribe to provide oversight of the Rapid City Indian trust land;
- WHEREAS,** the Tribes' Rapid City Indian Lands Committee shall meet quarterly and coordinate with Federal, state and local government officials as necessary and bring back, develop policies, recommendations and financial requests for the Rapid City Tribal Lands Committee by consensus, and bring the policies, recommendations, and financial requests back to each Tribe for ratification thereof;
- WHEREAS,** the legal description of the Tribe's Rapid City Indian lands is annexed hereto as Appendix 1;
- WHEREAS,** to ensure appropriate risk management each Tribe will include the Rapid City Indian Lands on its general liability/property insurance;
- WHEREAS,** NDN Collective is a national nonprofit organization based In Rapid City, South Dakota. NDN Collective exists to build Indigenous power through defense, development and decolonization, and take control of our destinies. NDN Collective will focus on three primary goals: 1) Increase philanthropic and capital investment in Indigenous-led organizations, communities, people, tribes, and movements. 2) Improve the capacity and skills of Indigenous-led organizations, communities, people, tribes, and movements. 3) Advance the rights of Indigenous Peoples through organizing, agenda-setting, activism, and political actions. NDN Collective is located at 317 Main Street, Suite 1, Rapid City, SD 57701.
- WHEREAS,** the NDN Collective has identified a need for additional support for the Rapid City Lakota-Dakota-Nakota Homeless Community in Rapid City and has established a Homeless camp on the Tribe;
- WHEREAS,** the NDN Collective's long-term goal is to acquire facilities for a permanent Lakota-Dakota-Nakota Homeless Shelter in Rapid City, SD and NDN Collective has an initial plan for acquisition of land and facilities and the Tribes support this long-term goal;
- WHEREAS,** the Tribal Rapid City Indian Land Committee shall oversee the Permit for a Temporary Homeless Camp on the Tribes' Rapid City Indian Lands;
- WHEREAS,** NDN Collective shall make all necessary plans and precautions to safeguard the life, public health and safety of the Lakota-Dakota-Nakota Homeless people at the *Mni Luzahan* Lakota-Dakota-Nakota Homeless Camp;

WHEREAS, the NDN Collective estimates that 10 acres would suffice for the homeless camp and there is a need for improvements to develop the campsite, including:

- Well for Water;
- Septic Tank;
- Stone FirePlace and Grill;
- Public Toilet/Shower Facility for Campers; and
- Driveway Improvement;

The Tribes shall make a joint request for \$50,000 in funding of these facilities to the BIA and IHS;

WHEREAS, the requirements for NDN Collective as Permittee for the operation the Lakota-Dakota-Nakota Homeless Camp shall include:

- Alcohol and Drug Free Camp: NDN Collective shall operate the Lakota-Dakota-Nakota Homeless Camp as an Alcohol and Drug Free Facility, and possession and/or use of alcohol and drugs on the premises shall be prohibited;
- Overall Occupancy: Occupancy shall be limited to 200 temporary residents/campers. Guests shall be limited and by permission of the Permittee with hours limited from 10 a.m. to 8 p.m.;
- Compliance with Applicable Laws and Regulations: NDN Collective shall operate the camp in compliance with Applicable Tribal Laws and Regulations;
- Maintenance of Orderly, Sanitary and Safe Camp: NDN Collective shall maintain an orderly camp for Lakota-Dakota-Nakota Homeless. NDN Collective shall provide appropriate Camp Supervision and maintain public safety, health, sanitation, and general welfare of the Camp;
- Public Safety: Tribal Law Enforcement shall be provided by the Oglala Sioux Tribe with the assistance of the BIA and any offenses shall be enforced through the Oglala Sioux Tribal Courts on behalf of all three Tribal Governments.
- Trash Collection/Removal: Permittee shall arrange for appropriate trash removal and collection and maintain sanitary collection sites;
- Sanitary Facilities: Permittee shall ensure that Port-a-Johns shall be maintained in adequate quantity, with regular cleaning and rotation to ensure public health and safety. Human waste shall be confined to Port-a-Johns to maintain public health;
- Potable Water: Permittee shall ensure that adequate potable water is available to homeless camp residents for drinking, household uses, cleaning, and sanitation;
- Electricity: In coordination with the Tribal Government Land Committee, the Permittee shall arrange for an electric hook-up for the camp to provide lighting, etc., and shall consult with a professional electrician to avoid electrical failure and safety issues;

- Fire: Permittee shall confine any fires to communal stone fire places and/or grills and/or fire rated wood stoves; Permittee shall consult with the Tribal Government Land Committee concerning construction/placement of fire places and/or grills; Camp fires shall be fully extinguished; Cooking shall be limited to designated cooking areas/grills;
- Driveway: Permittee shall consult with the Tribal Government Land Committee concerning the construction of a gravel driveway to provide necessary access to the camp. Construction of said driveway shall be at Permittee's expense, unless otherwise agreed in writing by the Tribal Governments. Motorized travel is limited to the driveway;
- Insurance and Indemnity: Permittee shall maintain a general liability insurance policy with minimum \$1,000,000 per occurrence/\$5,000,000 aggregate coverage limits to cover camp activities and premises. Permittee shall hold harmless and indemnify the Tribal Governments for any loss suffered due to the camp;
- Protection/Preservation of Land: Permittee shall be responsible to protect and preserve the land and environment. If any cultural properties are discovered, the cultural properties shall not be disturbed and the Permittee shall notify the Tribal Government Land Committee;
- Animals: To protect human health and public safety, pets and other animals shall not be permitted at the campground;

WHEREAS, NDN Collective as Permittee shall coordinate with the Tribal Government Land Committee on any interactions with the BIA, State, or Local Governments; The Tribal Governments shall manage necessary intergovernmental interactions and when necessary shall invite NDN Collective and others as necessary;

WHEREAS, the Permit to NDN Collective is governmental/charitable in nature and is freely revokable for non-compliance therewith and other reasons at the sole determination of the Tribes;

WHEREAS, Any organization or entity assisting NDN Collective with the operation and maintenance of the temporary Homeless Camp shall abide by Permittee's supervision and operation of the camp, subject to the oversight of the Tribal Land Committee, and shall countersign a copy of this agreement to indicate its assent thereto;

NOW THEREFORE BE IT RESOLVED that the Cheyenne River Sioux Tribe agrees to issue the annexed Temporary Camp Permit (Appendix 2) in accordance with the requirements above;

BE IT FURTHER RESOLVED that the Tribal Council authorizes the request for initial BIA funding for Facilities for the Temporary Homeless Camp;

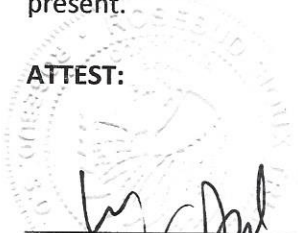

**RESOLUTION ON LAKOTA-DAKOTA-NAKOTA TEMPORARY HOMELESS CAMP
ON THE TRIBES' RAPID CITY INDIAN TRUST LAND**

- WHEREAS,** the Cheyenne River, Oglala, and Rosebud Sioux Tribes (the "Tribes") own equal and undivided interests in approximately 117 acres of tribal trust lands in Rapid City, SD;
- WHEREAS,** The Tribes by adopting this Resolution hereby establish the Tribal Rapid City Indian Lands Committee composed of the Chairman or President of each Tribe and two additional members appointed by the respective Tribal Council from each Tribe to provide oversight of the Rapid City Indian trust land;
- WHEREAS,** the Tribes' Rapid City Indian Lands Committee shall meet quarterly and coordinate with Federal, state and local government officials as necessary and bring back, develop policies, recommendations and financial requests for the Rapid City Tribal Lands Committee by consensus, and bring the policies, recommendations, and financial requests back to each Tribe for ratification thereof;
- WHEREAS,** the legal description of the Tribe's Rapid City Indian lands is annexed hereto as Appendix 1;
- WHEREAS,** to ensure appropriate risk management each Tribe will include the Rapid City Indian Lands on its general liability/property insurance;
- WHEREAS,** NDN Collective is a national nonprofit organization based In Rapid City, South Dakota. NDN Collective exists to build Indigenous power through defense, development and decolonization, and take control of our destinies. NDN Collective will focus on three primary goals: 1) Increase philanthropic and capital investment in Indigenous-led organizations, communities, people, tribes, and movements. 2) Improve the capacity and skills of Indigenous-led organizations, communities, people, tribes, and movements. 3) Advance the rights of Indigenous Peoples through organizing, agenda-setting, activism, and political actions. NDN Collective is located at 317 Main Street, Suite 1, Rapid City, SD 57701.
- WHEREAS,** the NDN Collective has identified a need for additional support for the Rapid City Lakota-Dakota-Nakota Homeless Community in Rapid City and has established a Homeless camp on the Tribe;
- WHEREAS,** the NDN Collective's long-term goal is to acquire facilities for a permanent Lakota-Dakota-Nakota Homeless Shelter in Rapid City, SD and NDN Collective has an initial plan for acquisition of land and facilities and the Tribes support this long-term goal;
- WHEREAS,** the Tribal Rapid City Indian Land Committee shall oversee the Permit for a Temporary Homeless Camp on the Tribes' Rapid City Indian Lands;
- WHEREAS,** NDN Collective shall make all necessary plans and precautions to safeguard the life, public health and safety of the Lakota-Dakota-Nakota Homeless people at the *Mni Luzahan* Lakota-Dakota-Nakota Homeless Camp;

- Fire: Permittee shall confine any fires to communal stone fire places and/or grills and/or fire rated wood stoves; Permittee shall consult with the Tribal Government Land Committee concerning construction/placement of fire places and/or grills; Camp fires shall be fully extinguished; Cooking shall be limited to designated cooking areas/grills;
- Driveway: Permittee shall consult with the Tribal Government Land Committee concerning the construction of a gravel driveway to provide necessary access to the camp. Construction of said driveway shall be at Permittee's expense, unless otherwise agreed in writing by the Tribal Governments. Motorized travel is limited to the driveway;
- Insurance and Indemnity: Permittee shall maintain a general liability insurance policy with minimum \$1,000,000 per occurrence/\$5,000,000 aggregate coverage limits to cover camp activities and premises. Permittee shall hold harmless and indemnify the Tribal Governments for any loss suffered due to the camp;
- Protection/Preservation of Land: Permittee shall be responsible to protect and preserve the land and environment. If any cultural properties are discovered, the cultural properties shall not be disturbed and the Permittee shall notify the Tribal Government Land Committee;
- Animals: To protect human health and public safety, pets and other animals shall not be permitted at the campground;

WHEREAS, NDN Collective as Permittee shall coordinate with the Tribal Government Land Committee on any interactions with the BIA, State, or Local Governments; The Tribal Governments shall manage necessary intergovernmental interactions and when necessary shall invite NDN Collective and others as necessary;

WHEREAS, the Permit to NDN Collective is governmental/charitable in nature and is freely revokable for non-compliance therewith and other reasons at the sole determination of the Tribes;

WHEREAS, Any organization or entity assisting NDN Collective with the operation and maintenance of the temporary Homeless Camp shall abide by Permittee's supervision and operation of the camp, subject to the oversight of the Tribal Land Committee, and shall countersign a copy of this agreement to indicate its assent thereto;

NOW THEREFORE BE IT RESOLVED that the Cheyenne River Sioux Tribe agrees to issue the annexed Temporary Camp Permit (Appendix 2) in accordance with the requirements above;

BE IT FURTHER RESOLVED that the Tribal Council authorizes the request for initial BIA funding for Facilities for the Temporary Homeless Camp;

BE IT FURTHER RESOLVED that the Tribal Council authorizes the formation of the Tribal Rapid City Indian Land Committee in accordance with this Resolution and appoints the Chairman or President and following Tribal Rapid City Indian Land Committee Members for a 2 year term: 1) Russell Eagle Bear, and Pam Kills In Water.

WHEREAS, the NDN Collective estimates that 10 acres would suffice for the homeless camp and there is a need for improvements to develop the campsite, including:

- Well for Water;
- Septic Tank;
- Stone FirePlace and Grill;
- Public Toilet/Shower Facility for Campers; and
- Driveway Improvement;

The Tribes shall make a joint request for \$50,000 in funding of these facilities to the BIA and IHS;

WHEREAS, the requirements for NDN Collective as Permittee for the operation the Lakota-Dakota-Nakota Homeless Camp shall include:


- Alcohol and Drug Free Camp: NDN Collective shall operate the Lakota-Dakota-Nakota Homeless Camp as an Alcohol and Drug Free Facility, and possession and/or use of alcohol and drugs on the premises shall be prohibited;
- Overall Occupancy: Occupancy shall be limited to 200 temporary residents/campers. Guests shall be limited and by permission of the Permittee with hours limited from 10 a.m. to 8 p.m.;
- Compliance with Applicable Laws and Regulations: NDN Collective shall operate the camp in compliance with Applicable Tribal Laws and Regulations;
- Maintenance of Orderly, Sanitary and Safe Camp: NDN Collective shall maintain an orderly camp for Lakota-Dakota-Nakota Homeless. NDN Collective shall provide appropriate Camp Supervision and maintain public safety, health, sanitation, and general welfare of the Camp;
- Public Safety: Tribal Law Enforcement shall be provided by the Oglala Sioux Tribe with the assistance of the BIA and any offenses shall be enforced through the Oglala Sioux Tribal Courts on behalf of all three Tribal Governments.
- Trash Collection/Removal: Permittee shall arrange for appropriate trash removal and collection and maintain sanitary collection sites;
- Sanitary Facilities: Permittee shall ensure that Port-a-Johns shall be maintained in adequate quantity, with regular cleaning and rotation to ensure public health and safety. Human waste shall be confined to Port-a-Johns to maintain public health;
- Potable Water: Permittee shall ensure that adequate potable water is available to homeless camp residents for drinking, household uses, cleaning, and sanitation;
- Electricity: In coordination with the Tribal Government Land Committee, the Permittee shall arrange for an electric hook-up for the camp to provide lighting, etc., and shall consult with a professional electrician to avoid electrical failure and safety issues;




