**WHEREAS,** the Rosebud Sioux Tribe is a federally recognized Indian Tribe pursuant the Indian Reorganization Act of 1934 and all pertinent amendments thereof; and

**WHEREAS,** the Rosebud Sioux Tribe is governed by a Tribal Council made up of elected representatives who act in accordance with the powers granted to it by its Constitution and By-Laws; and

**WHEREAS,** the Rosebud Sioux Tribal Council is authorized to appropriate for public purposes of the Rosebud Sioux Tribe available Tribal Council funds pursuant to Article IV, Section 1 (g) of the Constitution and By-Laws of the Rosebud Sioux Tribe; and

**WHEREAS,** the purpose of RST Ordinance No. 88-12 is to implement Article IV of the Constitution and the By-Laws of the Rosebud Sioux Tribe to appropriate and publish the efficient allocation of resources to meet tribal needs and provide public services; and

**WHEREAS,** on September 18, 2019, the Rosebud Sioux Tribal Council at a regularly scheduled meeting approved a motion to start the loan process or line of credit for clothing orders and other Tribal Expenses in the amount not to exceed \$1,000,000.00; and

**WHEREAS,** on November 25, 2019, the Rosebud Sioux Tribal Council at a regular scheduled meeting approved the RST Enrollment Department's budget less the merit award amount for a total amount of \$762,500.00; and
