RST COVID-19 Task Force**

**In light of the on-going and swift response actions planned for and in emergent response for COVID-19, it is imperative that the Rosebud Sioux Tribe increase the ability and capacity to respond to, provide emergent care and transportation to local and distant healthcare facilities. The RST COVID-19 Task Force recognizes this emergent need and recommends to the Tribal Administration that a purchase of additional ambulances and equipment is necessary to ensure that adequate and safe transportations are being provided for the people of the Rosebud Reservation for both 911 and interfacility transports off the reservation. With the increase in GSA lease fees for ambulances, it is anticipated that it will cost the Rosebud Ambulance Service \$450,000.00 + yearly to lease these vehicles. Owning our fleet of ambulances is advantageous to the people's comfort and safety, as well as decreasing the overall cost of maintaining an ambulance fleet.**

**With this in mind, a quote (sole source) has been received from Arrow MFG. Inc., Rock Rapid, Iowa for five (5) vehicles and equipment: one (1) New 2020 Ford F450 4x4 Heavy Duty Ambulance with a total purchase price of \$261,400.00, one New (1) 2019 Dodge 4500 Heavy Duty Ambulance with a total purchase price of \$261,400.00, and three (3) remounts on 2021 Ford E450 4x2 Type III Ambulances for a total purchase price of \$201,400 each (\$604,200); grand total is \$1,127,000.**

**We request your concurrence on making this purchase as a sole-source, due to the immediate need and availability and for the reason that the quoted prices for the vehicles are subject to prior sale and to waive the procurement process required for purchases above \$10,000.00.**




