WHEREAS, the Rosebud Sioux Tribal Council is authorized to promulgate and enforce ordinances for the maintenance of law and order, and to safeguard the peace and morals, and general welfare of the Tribe, and to provide for the administration of justice, pursuant to the Rosebud Sioux Tribe Constitution and By-Laws Article IV Sections 1 (a), (k), and (m), and

WHEREAS, the Rosebud Sioux Tribe Budget and Finance Committee is established pursuant to RST Ordinance No. 80-07, as amended in 1995; and


