WHEREAS, The Rosebud Sioux Tribal Council enacted RST Resolution No. 2020-75, affirming the declaration of the President of the Rosebud Sioux Tribe that on March 13, 2020, a State of Emergency exists within the Tribe as it relates to the novel Coronavirus (COVID-19), said declaration was made after the World Health Organization (WHO) declared on March 11, 2020 that the imminent threat to public health and safety from the spread of COVID-19 was a global pandemic; and

WHEREAS, The Rosebud Sioux Tribe has established and enacted procedure for use by the departments and entities for the Rosebud Sioux Tribe and in accordance with Resolution No. 94-125; and

WHEREAS, The Rosebud Sioux Tribe directs and authorizes the RST Property and Supply Department to advertise and publish a request for proposals for a bid proposal to for bids for either the entire project or a portion of the project to be submitted by close of business on October 9, 2020, for the construction of one-hundred (100) small cabins, to be manufactured, completed and delivered by December 31, 2020; and


