

Richard Moves Camp will also provide staff consultation, training, technical support, expert advice and other services deemed necessary and appropriate in the delivery of substance use disorder and culturally relevant psychological treatment services. These services will begin June 15, 2019 and end on September 30, 2019. The total amount will not exceed \$15,600.00.
