



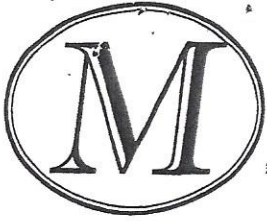

The jobs listed will be completed as specifications of previously printed material (within 14 months previous to this agreement. Any change in those specification may in turn change the value of these exchanges. If this is the case the print seller will have the right to bill for specifications above and beyond original valued purchase. After a proof (electronic file used to verify if the job is correct) is sent for a given Job, a notice will be given by the Print Buyer to go ahead with any given job. After it has been approved by the Buyer - it will be their responsibility to pay for any given job regardless of mistakes therein if Buyer has seen and agreed to proof with mistake within matching finished product. **WHEREAS**, the Sicangu Lakota Head Start Early Head Start requested sealed bids from June 15, 2020 and June 26, 2020 with an extended advertisement from July 6, 2020 to July 10, 2020; and

**WHEREAS**, the Rosebud Sioux Tribe Finance Dept. received one sealed bid from Curt Merriman Printing for \$56,500; and

**WHEREAS**, the SLO HS/EHS program is recommending the printing supplies contract be awarded to Merriman Printing in the amount of \$56,500; and


**WHEREAS**, the RST Budget & Finance Committee approved Merriman Printing for \$56,500 on Tuesday July 28, 2020; and
