
WHEREAS, Scotty's Ranchland will deliver the Holiday Hams to the RST Community Service Warehouse no later than December 18, 2020; now


WHEREAS, Scotty's Ranchland will deliver Holiday Turkeys to the RST Community Service Warehouse no later than November 20, 2020; now


