WHEREAS, the Rosebud Sioux Tribe is governed by a Tribal Council made up of elected representatives who act in accordance with the powers granted to it by its Constitution and By-Laws; and

WHEREAS, the Rosebud Sioux Tribal Council is authorized to appropriate for public purposes of the Rosebud Sioux Tribe available Tribal Council funds pursuant to Article IV, Sections 1 (g) of the Constitution and By-Laws of the Rosebud Sioux Tribe; and

WHEREAS, the Bureau of Indian Affairs, Regional Division of Facilities would like to consult with the Rosebud Sioux Tribe regarding the proposed Rosebud Agency Road Shop Roofing Project, building number sixty-three (63); and

WHEREAS, the Project consists of furnishing all materials, labor and equipment for the demolition, hazardous materials remediation/disposal, complete installation of membrane roofing system, interior ceiling and light replacement, and cleanup meeting the plans, specifications, direction and other attachments provided; and

WHEREAS, the estimated costs for the construction is \$261,134.70; and

WHEREAS, in accordance with the Assistant Secretary –Indian Affairs’ commitment to support Tribal Self-Governance and Self-Determination, we are soliciting the input of the Rosebud Sioux Tribe on the appropriate method of completing the potential project subject to the availability of funding; and

WHEREAS, the execution of the construction will be implemented using one the following options

Option one (1): PL 93-638 contract-the Rosebud Sioux Tribe may contract with the BIA-Division of Facilities using P.L. 93-638 Section 102 authority. The Contractor will be responsible for overall project management, status reporting, review of coordination with the Bureau of Indian Affairs, and completing all procurement actions, including the statement of work in accordance³ with all applicable federal, state and local building codes and standards, as well as the additional requirements identified by the Great Plains Region Division of Facilities (GPR-DF).

Option two (2): GPR-DF performs the activities-GPR-DF will be responsible for the overall project management in accordance will all applicable federal, state, and local building codes and standards.

THEREFORE BE IT RESOLVED, by the Rosebud Sioux Tribal Council selects Option One (1) to contract with the Bureau of Indian Affairs-Great Plains Region Division of Facilities (GPR-DF); and

BE IT FURTHER RESOLVED, that the Rosebud Sioux Tribal Council authorizes the Tribal President or the designated official to sign and execute all documents thereof.
