WHEREAS, The Rosebud Sioux Tribe is a federally recognized Indian Tribe organized pursuant to the Indian Reorganization Act of 1934 and all pertinent amendments thereof: and

WHEREAS, The Rosebud Sioux Tribe is governed by a Tribal Council made up of elected representatives who act in accordance with the powers granted to it by its Constitution and By-laws; and

WHEREAS, The Rosebud Sioux Tribal Council is authorized to promulgate and enforce ordinances for the maintenance of law and order, and to safeguard the peace and morals, and general welfare of the Tribe, pursuant to the Rosebud Sioux Tribe Constitution and By-Laws Article IV Sections i (k), and (m), and

WHEREAS, The Rosebud Sioux Tribal Council is authorized to negotiate with the Federal, State, and local governments on behalf of the Tribe, in accordance with the Rosebud Sioux Tribe Constitution and By-laws Article IV Section 1 (a); and

WHEREAS, Rosebud Sioux Tribe Law Enforcement Services has recommended the Rosebud Sioux Tribal Council authorize and adopt the use of Electronic Control Devices Rules and Procedures, to authorized the use and training in the use of Electronic Control Devices to gain control over individuals; and


THEREFORE BE IT RESOLVED, that the Rosebud Sioux Tribal Council adopts the recommendation of the RST Law Enforcement Services and approves the Rules and Procedures for the use of Electronic Control Devices, or Tasers;

BE IT FINALLY RESOVLED, that the Rosebud Sioux Tribal Council authorizes and directs the President of the Rosebud Sioux Tribe or his authorized delegate to sign and execute the appropriate documents for modify the Rosebud Sioux Tribe Law Enforcement Services, Public Law 93-638 Contract, to include the Rules and Procedures for the use of Electronic Control Devices or Tasers.




